

Healthcare Informed Consent

Healthcare Informed Consent: A record of a healthcare consumer's choices that permits or denies identified recipient(s) or recipient role(s) to perform one or more actions, within a given policy context, for specific purposes and periods of time

Four Types of Informed Consent in Healthcare



Privacy: agreement to collect, access, use, or disclose (share) information



Research: consent to participate in research study



Medical Treatment: consent to undergo a specific treatment/procedure (or record of refusal to consent)



Advance Care Directives: consent to access instructions for potentially needed medical treatment (eg, DNR)


Patient-Centered eConsent Model







Patient-Centered eConsent Model

- Patient access via a portal connected to a "personal cross-enterprise EHR" (PEHR)
- Patient creates a "personal healthcare team," selects providers on the team, and then chooses "document classes or types" that the team can access
 - Can restrict time period
 - Patient can view who has accessed what documents
- Interoperable with IHE-based architectures

Patient-to-Many Approach for Informed Consent

Industry shift to ACO models and growth of Patient-Centered Medical Homes are leading healthcare organizations to play a greater role in care delivery. This shift should also lead to a change in how informed consent should work

Instead of traditional patient-to-physician, informed consent should be between the patient and the organization, with other healthcare professionals involved in the patient's care included

Shared Decision-Making Model for HIE and ACP

- Research conducted to develop a user interface with iterative end-user feedback
- eConsent application intended for use by the patient to inform the patient of benefits and risks of sharing personal health information via an HIE
- Effectiveness of application-based eConsent only
 - 70% had moderate to low comprehension of HIE and implications of granting consent (ie, not well-informed)

The Problem


- Antiquated consent processes and information distributed across the web in myriad systems that are not easily accessible
- Current systems obstruct information sharing within and across sectors
- A critical need to improve racial equity, socioeconomic disparities and outcomes

The Goal

 Improve health, well-being and equity by significantly advancing consent services

The Need

- First examination/aggregation of consent-related activities in a decade
- Urgency in obtaining and utilizing learnings to inform action/implementations

What is a Community of Practice?

- A **Community of Practice** is a group of people who share a concern, a set of problems or a passion about a topic and who deepen their knowledge and expertise in this area by interacting on an ongoing basis
- **Domain** the shared interest that provides the incentive and passion for the group to come together.
- **Community** the group of people who come together with a common interest, who share their perspectives and knowledge with one another.
- Practice the agreed upon ways of formalizing and implementing the collectively developed knowledge and solutions that further the community's mission.
- This includes developing and implementing new technology or best practices, innovation and problem solving, conducting research, and developing standards.
